



Organisation Membership – Criteria and Requirements / Benefits

1. A registered company or organisation must have over one year of operation and with limited liability; or a training organisation or a public body. Also, it is actively involved in
 - Air, sea, rail, road, passenger or freight transport
 - Logistics
 - Transport or logistics related services
 - Transport or logistics related research and development organisation
2. An academic institution/research centre must be able to demonstrate its affiliation with a local university/college.
3. Membership Categories

Diamond Tier

- The Diamond Tier shall be by invitation or by application from a company/organisation having had OM status for 8 consecutive years, subject to the determination of the Council;
- The Diamond Tier has to be a registered company as mentioned in paragraph 1 above;
- This registered company or organisation in Hong Kong must have
 - a minimum of 12 full-time employees, and/or
 - a minimum paid-up capital of HK\$500,000 or above;
- Annual membership fee is HK\$78,000.

Gold Tier

- The Gold Tier has to be a registered company as mentioned in paragraph 1 above;
- This registered company or organisation in Hong Kong must have
 - a minimum of 12 full-time employees, and/or
 - a minimum paid-up capital of HK\$500,000 or above;
- Annual membership fee is HK\$38,000.

Silver Plus Tier

- The Silver Plus Tier has to be a registered company as mentioned in paragraph 1 above;
- This registered company or organisation in Hong Kong must have
 - a minimum of 6 full-time employees, and/or
 - a minimum paid-up capital of HK\$200,000 or above;
- Annual membership fee is HK\$18,000.

4. Company/Organisation must be committed to the promotion of the OM membership as "Partnership for People's Development in Logistics and Transport Industries".
5. Documents, publications or printouts to support the company's/organisation's conditions and the financial background, such as the Annual Report, Certificate of Business Registration and/or copy of the financial statement, must be enclosed with the application.
